After you have completed your application and send it in, be prepared to make a deposit of at least 50% for your booth space and have all documents signed and submitted...all fees due by July 15, 2020. The cost for a registration will increase in the amount of \$50.00, after **April 30, 2020**. At which time there is no guarantee that a spot will be available. Email applications to **info@trickyair.com** and we will contact you upon approval. Payment acceptable by credit card (VISA, MasterCard, or Discover, PayPal). \*All fees must be paid by July 15, 2020. If you have any issue meeting the deadline, please contact Maegan at **info@trickyair.com** prior to this date.

\*\*July 1, 2020 is the deadline for cancelations. Any and all cancelations will forfeit 25% deposit of the approved estimated total. Spaces are non-refundable/non-transferable after July 15, 2020.

Spaces cannot be shared or split. Each Vendor/Exhibitor must have their own registration form on file. Once approved, there cannot be changes made without notice and approval. Payments for upgrade must be paid before the deadline July 15, 2020. Applications will be reviewed on a first come, first serve basis. ## **Pro-Touring Truck Shootout 2020 Rules and Regulations Details**

**Application/Fees:** Pre-registraation is now open!! The Vendor/Exhibitor must have the 3 page application/agreement signed and pay the booth rental fees in full by the deadline of July 15, 2020. This application shall be subject to the approval by office management of The Pr-Touring Truck Shootout, and shall reserve the right to determine eligibility of Vendors/Exhibitors for this event and reserves the right to reject any application in the best interest of the event whether prior to or after the acceptance of this application. Acceptance of this application does not guarantee approval. 50% of the total fees is due upon application apporval. Be advised, pre-reg closes April 30, 2020, after this date the cost of booth space goes up \$50.

**Deposit/Cancellations:** 50% of the total of your fees are due upon app. approval. Upon cancelation, your request must be submitted in writing before the deadline of July 1st, 2020. Be advised, 25% of your total is NON-REFUNDABLE. The refund issued will be of the balance of fees paid, less 25% of the total bill. If you submit your cancelation request via email or post marked after the deadline (July 1st, 2020), Tricky Air & Billet, INC./ Pro-Touring Truck Shootout will hold the full amount of fees paid. NO refund /transfer will be approved at any time thereafter.

**Dinner:** Provided Saturday night only! Venders will be provided with 2 meal tickets at no additional charge to their Vendor/exhibitor fees. Each 2-day Autocross Truck entry also recieves 1 ticket. \*There is a \$10 fee for any additional invites on your behalf. You may pay for guests ahead of time, or your guest may pay for their ticket at the event. There is no guarentee there will be a ticket available at the event, as tickets will go fast. Dinner tickets are a priotity for event participants (Vendors/Exhibitors, Autocrossers, Truck Coral, pre-order add-on \$10 tickets, in that order) first, and then first come first serve at the event.

**Vendor/Exhibitor Space Assignment:** Booth Space assignment shall be established by the Pro-Touring Truck Shootout office management. Exhibit size must be specified on this application. If you wish to have your trailer at your booth, you must pay for ample booth space to equal the lenght of your trailer. This is a Must. There is no additional fee to have your trailer at your booth. Request for changes to booth size must be submitted by email to Maegan at info@trickyair.com prior to July 15, 2020. Vendors may not share, sublet, assign or apportion all or any part of the exhibit space given. Trailers, canopies, and trucks are acceptable at your booth. Vendors participating in the Autocross, you may park your truck in your booth, consider purchasing additional 10 X 10 space for use as a pit. Of course, use caution, No burnt outs or high speeds around spectators.

**Vendor Entry/Display Set Up:** Set up is on Friday, August 7th, 2020 from 7AM to 7PM. You cannot unload/set up during the event hours. Venders are encouraged to be prepared to set up earlier than later. Only Vendor/Exhibitor crew are allowed at the track on Friday. Contact us if there is an emergency situation that prevents you from arriving Friday for set up. Please keep your booth looking clean and professional. The Pro-Touring Truck Shootout is NOT responsibility for any Vendor/Exhibitor materials and/or personal possessions left unattended during set up. Please have your booth occupied at all times. \*Electrical power, there are NO electrical hookups available. You must bring your own generators and power cords.

**Tear Down:** Vendors/Exhibitors may not break down canopies, signs or displays until 5 PM on Sunday, unless instructed to do so by event officials. Be responsible for all materials, supplies, garbage, spills, and persoanl property. The Pro-Touring Truck Shootout personell are not responsible for any of the Vendor/Exhibitor materials and/or personal property left unattended.

**Conduct/Integrity:** The Pro-Touring Truck Shootout 2020 personel reserves the right to restrict Vendors/Exhibitors to appropriate and suitable methods of operation and displays of materials, banners and merchandise of offensive nature.
